## Summer School 2010 Enrollment Agreement

Thank you for selecting The de Paul School for your child's education. This Check list will help as you complete the Enrollment Agreement.

**Please read the complete agreement before you complete or sign anything.**

### **Frequently Asked Questions**

#### **How much does the Summer Program cost?**

Please refer to paragraph 15 of the agreement.

For Single Payment Plans:

If you opt only for the Academic Morning classes your total tuition will be \$1,400

If you select the Academic Morning Program and the Extended Morning Program your total tuition will be \$1,675

If you select the Academic Morning Classes and the Afternoon Camp Sessions your total tuition will be \$2,375

If you select all three summer program options, your total tuition will be \$2,650

#### **What is my obligation to pay?**

All deposits are non-refundable

You may withdraw your application before June 1, 2010 if you provide written notice to the Admissions office on or before June 1, 2010. Any deposits will be forfeited and any prepaid tuition will be refunded to you. See Enrollment Agreement paragraph 5.

After June 1, the full amount of tuition and all fees is due and payable on the schedule you select in the enrollment agreement. If your child leaves de Paul, for any reason, the full amount of tuition and all fees for the summer program is payable in full. No refunds of tuition will be given to students who do not complete the full summer program.

#### **How can I pay for the Summer Program?**

Please refer to paragraph 15 of the agreement.

You must remit a non-refundable deposit for each program selected with this application. You may pay the deposit by check, cash, or money order (credit/debit cards are not accepted). The non-refundable deposits required are:

Academic Morning Program - \$150  
Extended Morning Program - \$25  
Afternoon Camp Sessions - \$100

You may pay the balance (after deposits) of the program costs by check, cash, or money order (credit/debit cards are not accepted) on or before June 1, 2010.

You may apply for a student loan with one of the providers whose brochure is included in your enrollment packet. Please contact the provider for additional information.

You may pay the balance (after deposits) of the program costs in two payments. If you opt for the two payment plan, a plan administration fee of \$50 for the Academic Morning Program will be added, an administrative fee of \$30 will be added if you select the Afternoon Camp Sessions, and an administrative fee of \$5 will be added if you select the Extended Morning Program.

**I have selected the Two Payment Plan. When are payments due and how much are the payments?**

Payments must be made through a direct debit arrangement with your financial institution (your bank) and will be deducted from your account. Be sure to complete paragraph 17 and attach a voided check or deposit slip as indicated.

Your first payment will be deducted from your account on **June 7, 2010**

Your second payment will be deducted from your account on **July 5, 2010**

Payment amounts, including the administrative fee, are as follows:

Academic Morning Program - \$650 each payment  
Afternoon Camp Sessions - \$442.50 each payment  
Extended Morning Program - \$127.50 each payment

Total of Payments

Academic Morning Program + Afternoon Camp Session - \$1,092.50  
Academic Morning Program + Extended Morning Program - \$777.50  
All Three Programs - \$1,220

Be sure to review paragraph 8 – a \$30.00 fee will be added to your account if your financial institution should refuse the direct debit request for any reason. Rejected payments will be resubmitted on the next payment date.

## CHECKLIST

- Page 1 – Be sure to enter the student name
- Read the entire agreement
- Paragraph 15 – Step 1 – Select the payment plan.
- Paragraph 15 – Step 2 – Select the desired program options
- Paragraph 15 - Be sure to enter the correct totals in the boxes provided.
- Paragraph 15 – Remit the total deposit(s) due with the signed Enrollment Agreement
- Paragraph 17 – If you selected the TWO payment plan you must complete this section.
- Paragraph 17 – If you selected the TWO payment plan be sure that each account holder signs the direct debit agreement.
- Paragraph 17 – If you selected the TWO payment plan be sure to attach a voided check or deposit slip where indicated.
- Page 5 – Complete all information on this page. Please print legibly.
- Page 5 - Sign the agreement. Both parents must sign the agreement.
- Page 5 – If a third party will be responsible for payments, the responsible party must provide the required information and must sign the agreement along with the parent(s) or guardian.
