**Mission Statement**

The de Paul School's mission is to teach students with learning differences how to learn, how to be independent, and how to be successful.

**The Setting**

The de Paul School Extended Day Program, which will be held at The de Paul School, 1925 Duker Avenue, Louisville, Kentucky. The Extended Day Program will be headquartered in the gym.

**Our Students**

For SY 2020-21, the program will be restricted to current de Paul School students. The administration may admit siblings of de Paul School students on an exceptional basis.

**Goals**

1. To provide a safe and stimulating environment for students at the conclusion of the school day, allowing parents to pick up their children beyond regular dismissal time.
2. To provide a reliable study and homework station for de Paul students.
3. To provide light recreational and social opportunities for students beyond the school day.
4. To involve students with opportunities to collaborate and build community.

**Schedule**

The following is a sample afternoon for Extended Day Students.

3:30	Check-In and Snack
3:50	Homework and Study Table
5:00	Activity Centers (or Homework Table for those joining after club or sports participation)
6:00	Dismissal

- ❖ Extended Day is offered on each day when school is in session. That includes days with a noon dismissal.
- ❖ Extended Day is not in session on days when the school is closed. This includes holidays, professional days, weather-related closings, and conference days.
- ❖ Extended Day is available on scheduled half-days, with a modified schedule beginning at Noon and concluding at 6:00 pm.
- ❖ All students must be picked up by 6:00 pm. Chronic late pick-ups after 6:00 pm will be considered grounds for dismissal from the Extended Day program.

**Sign-Out of Students**

A parent or other approved adult will sign the student out for dismissal. No child will be released without first being signed out by an approved parent or adult. Each adult picking up will be screened through the Raptor Visitors Management System. The adult picking up must provide his/her approved identification (e.g., driver's license) upon arrival. The Raptor Technology then screens for any incidence of sexual offense.

**Program Visits**

The Extended Day program is closed to visitors, guests, or observers. We do not welcome visitors as this can disrupt the program's schedule and introduce distractions and even security concerns.

**Conduct**

An Extended Day participant must conduct himself or herself in a manner that demonstrates respect for self, fellow students, staff, and the school building. Any alleged misconduct within the program which compromises the safety of students and staff and/or which conflicts with the integrity of the program will be cause for immediate suspension or dismissal. The disciplinary expectations of the Extended Day program are completely aligned with those expectations which students agree to in the School Handbook. Having signed the School Handbook, the student has indicated agreement to those disciplinary expectations which also apply to Extended Day.

**Technology**

Cell phones and other communication devices are prohibited. They will be stored by the Coordinator during the program's hours. Any exceptions must be approved by the Coordinator.
